When the Red Guard was disbanded and absorbed into the RU on 1/22/69, the RU gained very few members and it was tacitly acknowledged that the Red Guard movement had not been successful. [redacted]

In view of information provided by [redacted] that the RU does not in fact have any control over the MFU, no further investigation is being conducted in this matter.
